## **ABOUT THE DEPARTMENT**

**Lackawanna College's Public Safety Department** is the branch of the college whose primary function is to assist students, faculty, staff and visitors in matters involving health and safety, order, information, parking and issues affecting upon student quality-of-life. Utilizing uniformed officers, the Public Safety Division's staff is easy to access and highly visible throughout the college's Scranton Campus.

Public Safety Officers function in many capacities. They regulate and enforce vehicle-parking regulations on campus; conduct random rounds throughout the campus to ensure a safe environment and check compliance with college rules and regulations; identify safety concerns, maintenance problems and security risks; offer assistance to anyone on the college's grounds; and investigate and resolve problems and complaints. To be successful in providing the highest degree of public safety services on the campus, it is important that community members follow good safety practices and understand that safety is a shared responsibility. This includes using the escort service, locking your valuables, and reporting suspicious/criminal activities. The Department of Public Safety takes a leadership role in this area, and includes education on campus safety, preventative patrols, incident investigation, crime reporting, fire safety and prevention, crime prevention, and community-policing.

All Public Safety Officers have been properly trained in the performance of their duties. Such training includes Cardio-Pulmonary Resuscitation (CPR), First Aid certification and lethal weapons training sufficient to qualify for Pennsylvania ACT 235 certification. All full time officers, however, vastly exceed these requirements and are qualified to serve as Municipal Police Officers having completed Pennsylvania's ACT 120 Training. In addition, they periodically attend advanced safety training courses.

Public Safety Officers exist to serve the college community so do not hesitate to request assistance when necessary. The Department of Public Safety maintains a close working relationship with the Scranton Police Department, Lackawanna County District Attorney's Office and the Pennsylvania State Police. The College also operates Educational Centers in Lake Region, New Milford, Towanda and the Cities of Hazleton and Sunbury. The staffs of these Centers work with both the Department of Public Safety and their respective municipal police in maintaining security.

## **Medical Emergencies**

Report all medical emergencies to the Department of Public Safety at the numbers listed above or by dialing 9-1-1. An officer will respond to your location and assist. All officers are certified in CPR and in the use of an AED. Officers are also certified in Emergency Response.

## **Reporting a Crime**

If you become a victim of and/or witness to a crime, immediately report the incident to the Public Safety Department. The sooner a crime is reported, the better the chances that we can solve the crime, apprehend the suspect and recover any property that may have been taken.

To report a crime contact the Department of Public Safety at the number listed above.

## **Emergency Notifications**

Campus wide notification regarding emergencies are issued via various means, including but not limited to text messaging, the college portal web page ([portal.lackawanna.edu](http://portal.lackawanna.edu)) and campus wide email. In order to receive text messaging notifications students, faculty and staff must sign up with the College's Emergency Notification System.

The College will initiate an emergency notification (active shooter, tornado or chemical spill) without delay and, taking into account the safety of the campus community, determine the content of the notification and initiate the notification system. That is, of course, unless a notification will, in the professional judgment of appropriate college officials, compromise efforts to assist a victim or contain, respond to, or otherwise mitigate the emergency.

## **Timely Notice (Warnings) / Community Advisories**

The Department of Public Safety will publish a crime alert within 24 hours of an incident to aid in the prevention of similar crimes. The notice will apply to all crimes listed in the Clery Act. An e-mail will be sent to the entire College community. Lackawanna College also communicates with other colleges and universities to exchange valuable and timely information.

## **Crime Log**

In compliance with federal law, Lackawanna College Public Safety maintains a crime log that provides a list of all crimes that occur on campus that have been reported. The crime log is updated daily and may be reviewed 24 hours a day, 7 days a week online at [portal.lackawanna.edu](http://portal.lackawanna.edu). In addition, the Director of Public Safety maintains a current up to date log that is available upon request.

## **Notice**

According to federal law, an institution may withhold any of the required fields of entry, i.e. the nature, date, time, location and/or disposition, if any of the following conditions apply:

- ✓ The disclosure is prohibited by law
- ✓ The disclosure would jeopardize the confidentiality of the victim
- ✓ The disclosure would jeopardize an on-going investigation or the safety of an individual
- ✓ The disclosure would cause a suspect to flee or evade detection
- ✓ The disclosure would result in the destruction of evidence.

## **Missing Students**

It is policy to follow official notification procedures for missing students who reside in on-campus housing in accordance with the Higher Education Opportunity Act of 2008.

If a member of the campus community has reason to believe that a student who resides on campus has been missing for 24 hours, the individual should immediately report the incident to the Department of Public Safety at the numbers listed above.

Should Public Safety determine that a student has been missing for more than 24 hours, Lackawanna College Public Safety Department will notify the local police department within appropriate jurisdictional authority.

If a missing person report is received on a student under the age of 18 years of age and not emancipated, contact will be made with the student's legal guardian.

## **Sex Offender Registry and Access to Related Information**

The Federal Campus Sex Crimes Prevention Act, enacted on October 28, 2000, went into effect October 28, 2002. The law requires institutions of higher education to issue a statement advising the campus community where law enforcement agency information provided by the Commonwealth concerning registered sex offender may be obtained.

It also requires sex offenders already required to register in a state to provide notice of each institution of higher education in that state which the person is employed, carries on a vocation, volunteer services or is a student.

### **Fire Alarms**

Lackawanna College takes Fire Safety seriously. All residence Halls at Lackawanna College have a state of the art fire system and are equipped and have water flow sprinklers systems as well as smoke detectors in each sleeping area. In addition, smoke detectors and fire extinguishers have been strategically placed in all buildings on campus to protect life and property. Fire extinguishers are checked on regular basis and tested annually in compliance with applicable laws.

The sophisticated alarm system is monitored 24 hours a day. Public Safety personnel are dispatched and respond immediately to any alarm condition. We value your privacy as well as your safety. Every attempt will be made to turn off the warning horns as soon as it has been ascertained that no danger exists. All students, visitors, faculty members, administrators and classified personnel must consider the ringing of the fire alarm as a bona fide emergency signal and react accordingly. Upon the sounding of the fire alarm, all rooms in the dormitory building will be evacuated in an orderly fashion and as rapidly as possible.

Vandalizing the alarm system, covering smoke detectors or illegally discharging fire extinguishers are serious offenses. Every effort will be made to identify persons who compromise public safety through such acts. Offenders will be charged by local law enforcement and also referred for appropriate disciplinary action.

### **SMOKING is not permitted in buildings**

### **Training:**

Fire prevention, evacuation and fire extinguisher training are provided for all Resident Directors, Resident Assistants and other staff members.

### **Fire Drills:**

Two Fire Drills are conducted each semester in residents' halls.

## Evacuation Procedures

1. If you discover a fire or smell smoke, sound the building fire alarm. Fire alarm pull stations are located at each exit.
2. When the fire alarm sounds, leave at once. Close all doors behind you. Proceed into the fire exit and leave the building. After leaving the building, keep moving for at least 200 feet and proceed to designated rally point. Do not reenter until given permission by appropriate college official.

*McKinnie Hall Residents staging area: parking area across from the dormitory on the corner of Vine and Wyoming Avenue. Use Caution when crossing the street.*

*Seeley Hall Residents staging area: proceed to parking lot of Healey Hall located across the street on North Washington Avenue. Use Caution when crossing the street.*

*Tobin Hall Residents staging area: proceed to the corner of Jefferson Avenue and Vine Street (the front of the Lackawanna College Student Union).*

3. Do not use elevators. Smoke could enter the elevator shaft thereby asphyxiating the occupants trying to evacuate the building therefore, the elevator will shut down upon the activation of the fire alarm.
4. Feel the door that leads from your area to the corridor before opening it. If it is hot or smoke is seeping in, do not open it. If you become trapped in your location and cannot reach the fire exit, keep the door closed and seal off any cracks. Use a phone and contact 9-1-1. Make sure you give your name and exact location to the dispatcher.
5. People with Mobility Limitations: A responsible person or persons that may be in the area of the person with a mobility limitation may be needed to assist in the event of a fire. These persons are taken into the fire exit and will remain on the landing. Once situated on the stairwell landing, dial 9-1-1 and let the dispatcher know the situation. Public Safety will respond and / or the local fire department to assist with your evacuation.
6. If caught in smoke or heat, stay low where the air is better. Take short breaths (through your nose) until you reach an area of refuge.

# **In An Effort to Improve Safety and Security**

## **Allied Universal**

As of the Fall Semester of 2018, Lackawanna College has retained the services of Allied Universal. Allied Universal is a recognized leader in the area of security, both at the industrial level and the collegiate level. Currently Allied Universal is providing staff to monitor the three residence halls at Lackawanna College. These Allied Universal officers are handing the reception desk at each residence hall from 3 PM to 7 AM, seven days a week. These officers have gone through a robust safety and security-training curriculum designed specifically for Colleges and University.

## **Electronic Swipe System**

At the college's main campus, entrance doors to all residence halls are locked at all times for the security of the residents. Residents Student ID Cards serve as a swipe card for entry into the doors of the resident halls. Propping the door or tampering with the door or its locking system is an offense that can lead to residence hall expulsion.

## **Building and Grounds**

Lackawanna College is diligent in maintaining the College's buildings and grounds, with special concern for safety and security. Repairs of a safety and security nature are made promptly. For example, outdoor lights are checked on a regular basis to ensure that burned out or damaged bulbs are replaced quickly.

In addition, each year classrooms and residence halls are inspected to insure that the buildings meet state and federal fire code. Defects are given priority and repaired promptly.

## **Digital Technology**

The College is also protected by digital technology using a state of the art security camera system. The system covers approximately 400 locations throughout the college's main campus. Each camera is in public view to reduce any concerns about privacy and to increase the deterrence factor.

## **Escorts**

The Department of Public Safety provides escorts on request for students, faculty and staff during evening hours when a person would feel safer by having an officer as an escort.

## **Student Wellness Programs/Services for Students**

Lackawanna College offers free, confidential information, and referral services for students about such things as:

Relationships, troubles with family, friends or romantic partners  
Difficulties arising from diversity issues  
Problems with food and nutrition  
Misuse of alcohol and/or drugs  
Stress resulting from academic and/or social pressures  
Troublesome feelings such as anxiety, depression, loneliness, shyness, fear, and anger  
Loss of a loved one or other bereavement  
Sexual assault or harassment

## **Inspections/Health and Safety**

In order to maintain a healthy, safe environment in the residence halls, the Office of Residence Life conducts room inspection several times during a semester. Fines are imposed for violations (such as possession of party lights, candles, and prohibited pets) or other infractions (for example, alcohol in a room). Fines may be imposed for each infraction.

During each student orientation session, a presentation on personal safety and crime reporting and prevention is given. These orientation sessions are done at the beginning of each semester.

In addition, the College has a very active Safety Committee, comprised of employees, both management and staff. This committee meets monthly. In addition, a safety review is conducted during annual employee evaluation conducted under the direction of the Department of Human Resources.

The following items are prohibited in the residence halls. Any items discovered at any time, e.g. during room inspections, will be confiscated and the resident/residents will be subject to disciplinary action.

- Appliances with open coils or burners, such as, but not limited to, broilers, toaster ovens, toasters, electric skillets, hot plates, hot pots, electric woks, hot dog and hamburger cookers, deep fryers, immersion coils or grills of any type to include, but not limited to George Foreman grills
- Explosive or flammable substances including fireworks, smoke bombs, sparklers, etc.
- Refrigerators and Microwaves (Lackawanna College now provides these items as part of each residence hall room)
- Any type of room heating device
- Incense, candles and open flame potpourri burners
- Octopus type plugs

- Halogen lights
- Live Christmas trees or flammable holiday decorations
- Weapons, paint guns, firearms or explosive devices
- Cinder blocks
- Empty alcohol containers
- Alcohol posters, advertisements, lights or signs
- Furniture without fire retardant material
- Nails, hooks, double faced adhesive tape or other items that will damage the walls
- Pets (See Resident Life Staff for service animals)
- Power cords without a multi-plug power strip with an internal circuit breaker
- Waterbeds
- Lofts
- Hover Boards
- Drones

### **Firearms Policy**

Weapons of any kind are prohibited on campus. This includes, but is not limited to, firearms, paint ball guns, dart guns, black or smokeless powder ammunition, knives, pen knives, swords, daggers and bayonets, martial arts weapons of any description and fireworks. Any item of any kind found in possession of a student anywhere on school property will be confiscated and turned over to the proper authorities as evidence following the protocol stated above. Possession of a weapon will lead to discipline including, but not limited to fines, probation and/or immediate dismissal from the College. If a student is dismissed from the College for a weapons possession offense, there will be no appeal unless granted, on a case-by-case basis, by the President of the College or his/her designee.

# *GENERAL POLICIES, PROCEDURES AND INFORMATION*

## **Student Behavior**

Lackawanna College has established a process for students to register complaints and share concerns and questions with appropriate College officials. The Student Affairs staff can advise students about the appropriate procedures to follow in resolving a general complaint or concern. Within three working days, the staff member to whom the complaint or concern is brought will respond to the student making the grievance. Each case will be handled individually and solutions can include, but are not limited to, solving the problem through informal channels up to and including filing formal charges.

Discrimination: Matters concerning alleged discrimination, especially concerning race, color, sex, religion, ancestry, national origin, age or handicap, should be brought to the immediate attention of the College's Affirmative Action Officers. Sexual Harassment: Sexual harassment is unwanted sexual or gender-based behavior that creates an environment that would reasonably be perceived, and is perceived by the victim, as hostile or abusive. It is the policy of Lackawanna College that sexual harassment is unacceptable and will not be tolerated.

Students are encouraged to bring questions about sexual harassment to the attention of the Affirmative Action Officers

Resolution of Student Complaints: The student should direct concerns to the staff member who is responsible for the area of concern. Students in doubt as to the appropriate staff member should seek the advice of a counselor or staff member. Depending on the nature of the concern, students can resolve problems by following the successive levels of review as indicated below.

Students not satisfied with results at one level should go on to the next level.

If a situation concerns alleged discrimination where steps other than the normal level-to-level ones are required, department heads/directors will be contacted immediately by an Affirmative Action Officer.

## **Sexual Discrimination Policy**

The College endorses and enforces Title IX of the Educational Amendments of 1972 that prohibits sexual discrimination against any participant in an educational program or activity that receives federal funds.

## **Harassment Policy**

Lackawanna College is committed to providing an educational and work environment that is free from discrimination in the form of harassment. In keeping with this policy, Lackawanna College will not tolerate any type of harassment related to race, color, sex, religion, national origin, age, sexual preference, or physical or mental disability. For these purposes, the term "harassment" includes, but is not necessarily limited to, slurs, jokes and other verbal, graphic or physical conduct relating to an individual's race, color, religion, sex, national origin, age or physical or mental disability.

Violation of this policy by any student, faculty or staff member shall subject that person to disciplinary action up to and including discharge or expulsion. Harassment is a form of illegal discrimination and violates The Civil Rights Act of 1964, as amended, The Civil Rights Act of 1991 and The Pennsylvania Human Relations Act.

## **Discrimination or Sexual Harassment**

Student files allegations with the Affirmative Action Officers. Lackawanna College is an equal employment and educational opportunity institution conforming to all applicable legislation, which prohibits discrimination. The College does not discriminate on the basis of race, color, sex, religion, ancestry, national origin, age, or applicable handicap in its educational programs, activities, admissions or employment practices as required by Title IX of the Educational Amendments of 1972, Section 504 of the Rehabilitation Act of 1973, and other applicable statutes. Inquiries concerning Title IX and/or 504 Compliance should be referred to: Mr. Brian Costanzo (Title IX Coordinator) or the Executive Director of Student Wellness or the Affirmative Action Officers.

## **Sexual Assault**

Public Safety staff is aware that sexual assault and rape are among the most traumatizing of all crimes. All of our officers understand that proper treatment of victims in these cases is of the utmost importance. In-service training, discussions and input from faculty and students is part of the process that Public Safety uses to prepare our officers to deal with these crimes. If such crimes occur, they will be handled with confidentiality and sensitivity and the victim will be given the full support of this department. Members of the Lackawanna College Public Safety are educated in Title IX and Clery Act requirements. The College will provide resource supporting those who have been sexually assaulted and will use appropriate disciplinary procedures against members of the College's community who violate the College's policies and State and Federal Laws. The informal and formal procedures are intended to afford a prompt response to charges of sexual assault, to maintain confidentiality and fairness consistent with applicable legal requirements and to impose appropriate sanctions on violators of the Sexual Assault policy.

Formal Complaints will be immediately reported to the Scranton Police Department and, whenever possible, the victim will be escorted to meet with members of that Police Department. All formal complaints will be treated confidentially and consistent with applicable legal requirements and customary law enforcement practices. Complainants will be advised of available support services, as well as legal and administrative options. Complainants will also be informed about the outcome of

any investigation conducted by the Department of Campus Safety Services and any disciplinary actions against the accused.

If a person reports to a College's administrator, department head, faculty member or member of the Department of Public Safety that she or he has been sexually assaulted, but chooses not to file a formal complaint at that time, then the complainant will be referred immediately to the SWC coordinator, and the person will be promptly notified of available support services on and off campus. Informal complaints will be treated with strict confidentiality and in accordance with applicable legal requirements. Additional information can be found in Appendix I

All appropriate sanctions and disciplinary actions will be coordinated by the Dean of Students and his/her staff. The Dean of Student Life will direct support services. The Department of Public Safety will assist both of these departments as needed.

# ***ALCOHOLIC BEVERAGE POLICY***

Lackawanna College does not condone the use of alcohol and prohibits the use or possession of alcohol on campus. Possession, use or consumption of alcohol or public drunkenness on any College property is strictly prohibited and can lead to disciplinary action, including separation from the College. **Being present where an alcohol violation is occurring is treated as possession.** Open canisters or empty containers apply as well, and will be treated as alcohol violations.

If a student is found to be in violation of the Alcoholic Beverage Policy, the minimum sanctions include:

## First Offense

- \$50 Fine
- Parental notification (*if age appropriate*)
- Written warning and a meeting with the Director of Residence Life (or designee)
- Three page paper addressed to Director of Residence Life (or designee) regarding alcohol and drug use, or completion of an on-line alcohol education program
- 5 hours of community service on campus

## Second Offense

- \$100 Fine
- Parental notification (*if age appropriate*)
- Mandatory attendance at a Lackawanna County drug court hearing or at a scheduled meeting with a third party counselor, as assigned
- 10 hours of community service on campus
- Probation

## Third Offense

- Dismissal from the College
- Parental notification (*if age appropriate*)

In addition to college penalties, all persons while in the Commonwealth of Pennsylvania are subject to the Pennsylvania Liquor and Penal Codes, (Source: PA Crimes Code Title 18). The following are violations of those codes: (*finest and punishments subject to change*)

- Misrepresentation of age to secure any alcohol, liquor or malt or brewed beverage – fine not to exceed \$500 and suspension of driver’s license.
- Individual less than twenty-one years of age purchasing, consuming, possessing or transporting any alcohol, liquor, malt or brewed beverage – fine not to exceed \$500 and suspension of driver’s license.
- Misrepresenting to liquor dealers or others that another party who is a minor is of age – fine not less than \$300.
- Inducement of minors to buy alcohol, liquor, malt or brewed beverage – fine not less than \$300.

- Selling or furnishing alcohol, liquor, malt or brewed beverages to minors – first violation fine not less than \$1000, subsequent violation fine not less than \$2500.
- Carrying false ID card – first offense is summary offense with restriction of driver’s license; subsequent offense results in restriction of driver’s license and fine of \$300.

## ***CONTROLLED SUBSTANCES POLICY***

Lackawanna College does not condone the use, possession, or distribution of any type of illegal drugs. The behavior and attitudes associated with the use of illegal drugs are detrimental to the individual student and the student body, and contrary to the mission and philosophy of the College.

Students charged with possession, use, or intent to distribute illegal drugs are subject to College disciplinary action, including dismissal from the College, independent of any external legal actions. In addition, eligibility for Federal Financial Aid may be subject to suspension or termination. **Loss of Title IV eligibility will result if a student is convicted of a state or federal offense involving the possession or sale of an illegal drug that occurred while the student was enrolled in school and receiving Title IV aid.**

While in the Commonwealth of Pennsylvania, all students are subject to Commonwealth law regarding possession and/or use of illegal drugs:

- Possession of any amount of marijuana is a misdemeanor - subject to a fine and/or possible imprisonment and a permanent arrest record.
- Possession of any other illegal substance including crack, LSD, cocaine, heroin, hashish, etc. – Subject to one-year imprisonment and/or \$5,000 fine and a permanent arrest record.
- Possession with intent to sell – subject to three to five years’ imprisonment and/or \$10,000 to \$1,000,000 fine and a permanent arrest record.

Students experiencing problems related to drug and/or alcohol use should do one of the following:

- Seek out a college representative for referral to an appropriate local agency for assistance.

- Contact Drug and Alcohol Treatment Service at 570 961-1997.
- Contact Alcoholics Anonymous at 570 347-1183

Every student making application for resident housing must sign a drug consent form prior to taking up residence on campus. A copy of the drug testing policy and procedure, as well as a testing consent form, is included in the packet of materials sent to prospective resident students. This form will remain in effect for the student’s entire time of enrollment at the College. Drug testing is performed randomly on a year-round basis. Students will be tested for cause and at random, intervals, which may be either announced or unannounced. The testing will be required at the sole

discretion of the College. There are no exceptions to this policy. All resident students will be required to comply. The student may be required to provide breath, blood, hair, and saliva and/or urine specimens for the purpose of analysis. Currently, Lackawanna College only uses urine specimens for the purpose of analysis. If the student is less than 18 years of age, the parent or legal guardian must sign the drug testing consent form in addition to the student. The signed consent must be returned to the College prior to the student's arrival.

## Crime Definitions

***Murder and Non-negligent Manslaughter*** – The willful (non-negligent) killing of one human being by another.

***Negligent Manslaughter*** – The killing of another person through gross negligence.

***Sex Offense Forcible (F)*** – Any sexual act directed against another person, forcibly and/or against that person's will; or not forcibly or against the person's will where the victim is incapable of giving consent: forcible rape; forcible sodomy; sexual assault with an object; and forcible fondling.

***Sex Offense Non Forcible (N)*** – Unlawful, non-forcible sexual intercourse: incest; statutory rape.

***Robbery*** - The taking or attempting to take anything of value from the care, custody, or control of a person or persons by force or threat of force or violence and/or by putting the victim in fear.

***Aggravated Assault*** – An unlawful attack by one person upon another for the purpose of inflicting severe or aggravated bodily injury. This type of assault is usually accompanied by the use of a weapon or by means likely to produce death or great bodily harm. It is not necessary for an injury to result when a gun, knife or other weapon is used in the commission of the crime.

***Burglary*** – The unlawful entry of a structure to commit a felony or a theft. For reporting purposes this definition includes: unlawful entry with intent to commit a larceny or felony; breaking and entering with intent to commit a larceny; housebreaking; safecracking; and all attempts to commit any of the aforementioned.

***Motor Vehicle Theft*** – The theft or attempted theft of a motor vehicle (Classify as motor vehicle theft all cases where automobiles are taken by persons not having lawful access even though the vehicles are later abandoned-including joyriding.)

***Arson*** – Any willful or malicious burning or attempt to burn, with or without intent to defraud, a dwelling house, public building, motor vehicle or aircraft, personal property of another, etc.

***Liquor Law Violation*** – The violation of laws or ordinances prohibiting: the manufacture, sale, transporting, furnishing, possessing of intoxicating liquor; maintaining unlawful drinking places; bootlegging; operating a still, furnishing liquor to a minor or intemperate person; using a vehicle for illegal transportation of liquor; drinking on a train or public conveyance; or any attempts to commit any of the foregoing violations. **Note: this list does not include public drunkenness and driving under the influence.**

***Drug Law Violation*** – Violations of State and local laws related to the possession, sale, use, growing, manufacturing, and making of narcotic drugs. The relevant substances include; opium or

cocaine and their derivatives (morphine, heroin, codeine); marijuana; synthetic narcotics (Demerol, methadone(s)); and dangerous non-narcotic drugs (barbiturates, Benzedrine).

***Weapon Law Violation*** – The violation of laws or ordinances regulating weapons.

***Hate Crimes*** – Any crime that manifests evidence that the victim was intentionally selected because of the victim's actual or perceived race; religion; gender; sexual orientation; ethnicity or physical/mental disabilities.

***Disciplinary Referrals*** – incidents in which a student was not arrested but was referred for campus disciplinary action for liquor law violations, drug law violations, and illegal weapons possession.

## **Location Definitions**

***Campus*** – (i) any building or property owned or controlled by an institution within the same reasonably contiguous geographic area and used by the institution in direct support of, or in a manner related to, the institution's educational purposes, including residence halls; and (ii) any building or property that is within or reasonably contiguous to the area identified in paragraph (i) of this definition, that is owned by the institution but controlled by another person, is frequently used by students and supports institutional purposes (such as a food or other retail vendor).

***Non-Campus*** – (i) Any building or property owned or controlled by a student organization that is officially recognized by the institution; or (ii) any building or property owned or controlled by an institution that is used in direct support of, or in relation to the institution's educational purposes, is frequently used by students, and is not within the same reasonably contiguous geographic area of the institution.

***Housing*** – Residence Halls or other university-owned residences.

***Public Property***–"public property" is defined by the Clery Act regulations as all public property including thoroughfares, streets, sidewalks, and parking facilities that is within the campus, or immediately adjacent to and accessible from the campus. Include the sidewalk across the street from your campus, but do not include public property beyond the sidewalk.

***The Violence Against Women Act (VAWA)*** - a landmark piece of federal legislation that sought to improve the criminal justice and community-based responses to domestic violence, dating violence, sexual assault and stalking in the United States. The passage of VAWA in 1994, and its reauthorization in 2000, 2005, and again in 2013 has changed the landscape for victims of domestic violence, dating violence, sexual assault and stalking.

# APPENDIX I

## What is Title IX

Title IX of the Education Amendment of 1972 is a federal Civil rights law that prohibits discrimination on the basis of sex in federally funded education programs and activities. Under Title IX, discrimination on the basis of sex can include sexual harassment or sexual violence, such as rape, sexual assault, sexual battery, and sexual coercion.

Lackawanna College has a duty in accordance with Title IX, to take immediate and appropriate action once it knows, or reasonably should have known, if any sexual misconduct/sexual harassment incidences.

If the sexual assault, sexual harassment, or sexual violence act Possess' an immediate threat to the college community, the college must issue an immediate warning to all members of the campus

### Notice of Non-Discrimination

Lackawanna College will not discriminate in its educational programs, activities, or employment practices, based on race, color, national origin, sexual orientation, disability, age, religion, ancestry, union membership, or any other legally protected classification. Announcement of this policy is in accordance with State Law including the Pennsylvania Human Relations Act and with Federal Law to include Titles VI and VII of the Civil Rights Act of 1964, Title IX of the Education Amendments of 1972, Sections 503 and 504 of the Rehabilitation Act of 1973, the Age Discrimination Act of 1975, and Americans With Disabilities Act of 1990.

## **Who is Covered by Title IX?**

Any educational institution receiving federal funding is covered by Title IX. Title IX applies to all members of the Lackawanna College community including students, staff, faculty, administrators, contractors, visitors, third parties, and to all programs and activities that take place either on or off campus.

*In accordance with Title IX of the Educations Amendments of 1972, Lackawanna College will not tolerate any type of sexual misconduct. All complaints of sexual misconduct should be brought immediately to the attention of Lackawanna College's Title IX Coordinator, Brian Costanzo (570) 961-7841 Or (570)241-2105.*

## **Our Title IX Coordinator**

The Title IX Coordinator is responsible for overseeing, investigating, and responding to all Title IX complaints. Responsibilities include:

- Receiving and investigating reports promptly and efficiently
- Training and educating faculty, staff, and students on Title IX compliance
- Reporting all incidences of sexual harassment, violence, and assault to Campus Safety in accordance with reporting requirements
- Maintaining confidential records of all formal and informal complaints of sexual misconduct

# Consent

**Consent:** An active and positive exchange of words or actions that indicate a willingness to participate freely and voluntarily in mutually agreed upon sexual activity.

## Consent is:

- ◆ Voluntary agreement to engage in sexual activity.
- ◆ Approval that can be withdrawn at any time.

## Consent cannot be given if a person is:

- ◆ Physically or mentally incapacitated due to alcohol or other drugs – this means if a person is drunk or high, they cannot give consent to engage in sexual activity.
- ◆ Unconscious.
- ◆ Asleep.
- ◆ Under the age of consent.
- ◆ Physically or mentally impaired.

**Remember, the only way to guarantee consent is to make sure it is offered verbally at each step of sexual activity.**

## Signs of Non-Consent

- ◆ **Verbal Refusal :** When someone says “no” or “don’t do that” or “please stop” or “I don’t want to do this.”
- ◆ **Implied Verbal Refusal:** When some says “I don’t think I want to go this fast” or “I’m not sure I want to do this.”
- ◆ **Physical Resistance:** Trying to get away, freezing up, trying to leave, rolling over or away, pushing away, moving someone’s hands, trying to put clothes back on.

**\*If sexual activity continues after any of these indicators, a crime has been committed.**

**Every individual has the right to give or withhold consent at any time and in any situation.**

**Stalking:** A course of conduct directed at a specific person that involves repeated visual or physical proximity, nonconsensual communication, or verbal, written, or implied threats, or a combination thereof, that would cause a reasonable person fear.

**Examples of this behavior include:**

- Repeated undesired contact (phone calls, emails, letters, show up unexpectedly, etc.).
- Following or laying in wait for the individual.
- Making threats to the individual or her/his family.
- Any other behavior used to contact, harass, track, or threaten the individual.

**Cyberstalking:** Threatening behavior or unwanted advances directed at another using the Internet and other forms of online and computer communications. The use of technology to stalk is increasing due to the rapid development of technology in today's world. Cyberstalking is a form of "personal terrorism." Similarly, cyberstalking may precede offline stalking, sexual assault, physical violence, or even murder.

**Cyberstalking can take forms such as:**

- Threatening/obscene emails.
- Live chat harassment or flaming (online verbal abuse).
- Harassment through texting.
- Hacking and/or monitoring a victim's computer and internet activity.
- Forming a website in honor of a victim.
- Off-line stalking/harassments such as following a victim or actual physical contact between a stalker and his/her victim.

Reporting the sexual assault is the choice of the victim, and reports may be filed through campus security, local police, and the Student Wellness Program. Reports made to campus officials are ensured to remain secure, as the College respects the dignity and worth of the individual and their rights to confidentiality.

**3) Preserve evidence**

This may include but is not limited to:

Do not bathe, change or dispose of clothing, use the restroom, wash your hands, brush your teeth, eat or smoke. If you are still in the location at which the assault occurred, do not clean anything. Write down all the details you can recall about the assault and the perpetrator.

**4) Get medical attention as soon as possible**

Seek professional medical attention for treatment of injuries sustained and for prevention of any sexually transmitted diseases that may occur due to the sexual assault. It is best to report incidences within 72 hours of when they occurred, and to preserve any evidence.

It is important to get medical attention because besides treatment for observable physical injuries, the possibility of the spread of sexually transmitted diseases (STD's) needs to be addressed following a sexual assault. An individual who has experienced an assault may be unaware of contracting a STD until symptoms appear. Also, it is possible to get pregnant from a sexual assault, and medical attention can help an individual address this concern.

## Lackawanna College

### Interim Measures

The college will promptly coordinate efforts with various departments to ensure the safety of the complainant and the campus community while the investigation is in process.

**Interim measures may include:**

- ◆ Counseling and academic support services.
- ◆ Changes in class schedules.
- ◆ Changes in work-study assignments (when reasonably available).
- ◆ Changes in on-campus housing (when reasonably available).
- ◆ Issuance of no-contact orders
- ◆ On-campus escort between classes and on-campus activities.
- ◆ Rescheduling of exams/assignments with no penalty.

Other measures may be made that pose the least amount of burden to the complainant.

## Lackawanna College

### Retaliation

Lackawanna College strictly prohibits retaliation (this includes, but is not limited to teasing, intimidation, coercing, and threats) to the complainant and witnesses by the perpetrator and their associates.

Reports of retaliation should be immediately made to the Title IX Coordinator. Lackawanna College treats all retaliation claims with the most sincere urgency and will investigate all reports and enforce the appropriate disciplinary procedures against violators of this policy.

The Student Wellness Program will provide follow-up counseling with the victim to ensure that no retaliation has occurred. If the victim notifies the Student Wellness Program or other staff/faculty/administrator or other responsible employee of incidences of retaliation, it is imperative that the Lackawanna College staff inform the Title IX Coordinator so that prompt measures and disciplinary actions may be taken against the perpetrator (s).

## **Prevention Education**

Lackawanna College will continuously develop new training and materials to educate and inform students/faculty/staff on sexual assault, sexual violence, sexual harassment, domestic violence, and stalking.

This education will begin by providing students with a copy of the Sexual assault Awareness and Prevention Handbook, and continue with presentations to students regarding the content of the handbook.

Topics covered: defining and discussing sexual assault, defining and discussing consent, discussion about victim blaming, providing information regarding risk reduction and raising awareness, providing information regarding steps to take in the event a sexual assault occurs and resources available, a discussion about the risk of disease or pregnancy when a sexual assault occurs, and an introduction to campus security and campus supportive services.

### **Enforcement of Title IX**

# APPENDIX II

## Definitions & Terms: VAWA Amendments to Clery

1. **Sexual Assault:** An offense that meets the definition of rape, fondling, incest, or statutory rape as used in the FBI's UCR Program.
2. **Sex Offenses:** Any sexual act directed against another person, without the consent of the victim, including instances where the victim is incapable of giving consent.
  - Rape- The penetration, no matter how slight, of the vagina or anus with any body part or object, or oral penetration by a sex organ of another person, without the consent of the victim.
  - Fondling- The touching of the private body parts of another person for the purpose of sexual gratification, without the consent of the victim, including instances where the victim is incapable of giving consent because of his/her age or because of his/her temporary or permanent mental incapacity.
  - Incest –Sexual intercourse between persons who are related to each other within the degrees wherein marriage is prohibited by law.
  - Statutory Rape –Sexual intercourse with a person who is under the statutory age of consent.
3. **Domestic Violence:** A felony or misdemeanor crime of violence committed
  - By a current or former spouse or intimate partner of the victim; by a person with whom the victim shares a child in common;
  - By a person who is cohabitating with, or has cohabitated with, the victim as a spouse or intimate partner;
  - By a person similarly situated to a spouse of the victim under the domestic or family violence laws of the jurisdiction in which the crime of violence occurred;
  - By any other person against an adult or youth victim who is protected from that person's acts under the domestic or family violence laws of the jurisdiction in which the crime of violence occurred.
4. **Dating Violence:** Violence committed by a person who is or has been in a social relationship of a romantic or intimate nature with the victim.
  - The existence of such a relationship shall be determined based on the reporting party's statement and with consideration of the length of the relationship, the type of relationship, and the frequency of interaction between the persons involved in the relationship.
  - For the purposes of this definition, dating violence includes, but is not limited to, sexual or physical abuse or the threat of such abuse.
  - Dating violence does not include acts covered under the definition of domestic violence.
  - Any incident meeting this definition is considered a crime for the purposes of Clery Act reporting.
5. **Stalking:** Engaging in a course of conduct directed at a specific person that would cause a reasonable person to
  - Fear for the person's safety or the safety of others; or
  - Suffer substantial emotional distress.

For the purposes of this definition:

- *Course of conduct* means two or more acts, including, but not limited to, acts in which the stalker directly, indirectly, or through third parties, by any action, method, device, or means, follows, monitors, observes, surveils, threatens, or communicates to or about a person, or interferes with a person's property.
- *Reasonable person* means a reasonable person under similar circumstances and with similar identities to the victim.
- *Substantial emotional distress* means significant mental suffering or anguish that may, but does not necessarily require medical or other professional treatment or counseling.
- Any incident meeting this definition is considered a crime for the purposes of Clery Act reporting.

6. **Programs to prevent dating violence, domestic violence, sexual assault, and stalking:** Comprehensive, intentional, and integrated programming, initiatives, strategies, and campaigns intended to end dating violence, domestic violence, sexual assault, and stalking that:

- Are culturally relevant, inclusive of diverse communities and identifies, sustainable, responsive to community needs, and informed by research or assessed for value, effectiveness, or outcome and
- Consider environmental risk and protective factors as they occur on the individual, relationship, institutional, community, and societal levels.

7. **Awareness programs:** Community-wide or audience specific programming, initiatives, and strategies that increase audience knowledge and share information and resources to prevent violence, promote safety, and to reduce perpetration.

8. **Bystander Intervention:** safe and positive options that may be carried out by an individual or individuals to prevent harm or intervene when there is a risk of dating violence, domestic violence, sexual assault, or stalking. Bystander intervention includes:

- Recognizing situations of potential harm
- Understanding institutional structures and cultural conditions that facilitate violence, overcoming barriers to intervening, identifying safe and effective intervention options, and taking actions to intervene

9. **Ongoing Prevention and Awareness Campaigns:** Programming, initiatives, and strategies that are sustained over time and focus on increasing understanding of topics relevant to and skills for addressing dating violence, domestic violence, sexual assault, and stalking, using a range of strategies with audiences throughout the institution.

10. **Primary Prevention Programs:** Programming, initiatives, and strategies informed by research or assessed for value, effectiveness, or outcome that are intended to stop dating violence, domestic violence, sexual assault, and stalking before they occur through promotion of positive and healthy behaviors that foster healthy, mutually respectful relationships and sexuality, encourage safe bystander intervention, and seek to change behavior and social norms in healthy and safe direction.

11. **Risk Reduction:** Options designed to decrease perpetration and bystander inaction, and to increase empowerment for victims in order to promote safety and help individuals and communities address conditions that facilitate violence.

12. **Prompt, Fair, and Impartial Proceeding:** A proceeding that is completed with reasonably prompt timeframes designated by an institution's policy, including a process that allows for the extension of timeframes for good cause and with written notice to the accuser and the accused of the delay and reason for the delay.

Conducted in a manner that:

- Is consistent with the institution's policies and transparent to the accuser and accused
- Includes timely notice of meetings at which the accuser or accused, or both, may be present; and
- Provides timely and equal access to the accuser, the accused, and appropriate officials to any information that will be used during informal and formal disciplinary meetings and hearings; and
- Conducted by officials who do not have a conflict of interest or bias for or against the accuser or accused

13. **Advisor:** Any individual who provides the accuser or accused support, guidance, or advice
